



Safety of School Children travelling in Private Vans

In view of the safety concerns about private vans being hired by parents for ferrying their children to school and guidelines issued by government from time to time, parents are hereby requested to ensure the following:

1. Check the license and license expiry and police clearance certificate (PCC) of the van driver; keep a copy of the same and provide a copy to the school.
2. Ensure that there is a lady attendant / mother volunteer always present in the van.
3. Check whether the driver is fit to drive the van in the morning / afternoon, and not under any kind of intoxication.
4. Check whether the van is following all safety norms with regard to overloading / making children sit on gas cylinder etc.
5. Speed governors are fitted in the vehicles and children are not left on the road in case of vehicle breakdown.
6. Ensure that children are travelling by authorised vans which have commercial yellow number plates. (Vans with white number plates are private vans and are unauthorised to ferry school children).
